We are pleased to provide the following information regarding compliance with US Environmental Protection Agency (EPA), California Air Resource Board (CARB) and the Canadian Environmental Protection Agency formaldehyde emission regulations for composite panels.

All ARAUCO North America composite panel products are third party certified to the CPA 4-19 Eco- Certified Composites (ECC) Sustainability Standard, California Air Resources Board (CARB) Airborne Toxic Control Measure (ATCM) 93120 regulation and the US EPA TSCA VI Formaldehyde Emission Standards for Composite Wood Products 40 C.F.R. Part 770. Compliance with the Canadian EPA SOR/2021-148 CANFER Formaldehyde Emissions from Composite Wood Products Regulations is demonstrated through US EPA TSCA VI certification with the provisions of the required declaration of certification and required labelling in both French and English ("TSCA Title VI compliant / conforme au titre VI de la TSCA"). As such, we comply with all applicable requirements of these regulations including quality assurance, emissions testing, labelling, record keeping, declaration of certification (CANFER), and the application of required compliance statements on bundle tags, invoices and bills of lading.

As specified by these regulations, only companies that have achieved third party certification may in turn apply the statement of compliance on regulated composite wood products. ARAUCO NA panel mills are third-party certified by the Composite Panel Association (TPC-1) and provide the requisite statement of compliance labelling on both product tags and sales and delivery documents (invoices and bills of lading). Customers or other interested parties that may request verification of ARAUCO's compliance to these regulations are directed to ARAUCO North America CARB/ TSCA VI / CANFER certificates, which can be accessed on <u>ma.arauco.com</u> under the "Resources" section, as well as to the statement of compliance on unit tags and other transactional documentation as received by customers from ARAUCO NA. TPC compliance test results are available to customers upon request.
